On September 28, 2021, Herndon Police Department obtained a warrant for aggravated sexual battery for Kelvin Herrera Delgado, now 39, of Herndon, VA. The charge stemmed from an incident in which he sexually assaulted a female victim under the age of 13 who was known to him. On August 8, 2024, Delgado was the striking vehicle in a hit and run accident. During the accident investigation, Delgado's arrest warrant was found on file. He was arrested and taken to the Fairfax County Adult Detention Center where he was held without bond.
