Aggravated Malicious Wounding 10/6/2024 13000-blk Worldgate Dr 2024-4062

As stated in previous news releases, Mohamed Abdalla, 25, of Ashburn, VA was arrested and charged with four felonies: aggravated malicious wounding, use of firearm in the commission of a felony, and two counts of abduction. The charges stem from an altercation with the victim that is known to him, in which Abdalla fired multiple shots at the victim. Abdalla remains in custody at the Fairfax County Adult Detention Center.
