## SECTION I: MAJOR INCIDENTS

**Burglary-Commercial**

**400-blk Elden St**

At 12:45 AM on Thursday, October 31, 2024, the business's alarm company informed the owner of an alert within the business. When the owner arrived on the scene, he observed an unknown number of subjects in the store who ran off when they saw the owner pull up. Officers were called and responded to the scene. After doing a sweep of the business, no individuals were located inside. The business initially appeared to be secure, but it was later determined that subjects appeared to have entered the front and rear doors of the business with some amount of force. Further investigation found there was a hole cut through the common wall connecting this business and the business next door. It is unknown if the subjects utilized the hole. An undisclosed amount of merchandise was stolen. A Fairfax County Police Department K9 Unit was called to track the suspects. FCPD's Fairfax 1 helicopter was also deployed to assist in the search. The investigation is ongoing.
