#### Aggravated Sexual Battery 9/29/2024 500-blk Florda Ave 2024-03942

Rudis Alexander Barahona Mineros, 21, of Herndon, VA, was arrested and charged with aggravated sexual battery against a 9-year-old victim that is known to him. He was taken to the Adult Detention Center where he was held without bond.

#### Burglary-Commercial 11/5/2024 1000-blk Elden St 2024-04467

Officers responded to the business at 9:00 AM after a call from a passerby who noticed the front glass door had been shattered. A review of security footage showed that two subjects forced entry into the building at 4:30 AM. Display cases inside were destroyed and an undisclosed amount of merchandise and cash was stolen. The case is under investigation.

#### Attempted Sexual Battery 11/5/2024 1000-blk Alabama Dr 2024-04468

The female victim reported that a male roommate inappropriately touched her and tried to kiss her. After telling him twice to stop, the male subject stopped and let her go. The victim did not want to press charges and moved out of the residence.

#### Sexual Battery 11/9/2024 800-blk Ferndale Ave 2024-04534

Carlos Andres Portillo Chavez, 19, of Sterling, VA, was arrested for sexual battery for inappropriately touching the 14-year-old victim after the two were at the same social function. He was taken to the Fairfax County Adult Detention Center where he was held on a \$5000 unsecured bond.
