## Corporate Membership Option 1:

We'll keep track of the number of employee visits per month and you pay for those visits at the end of each month. You'll receive a discount depending on the number of visits per month.

1-100 visits	10% discount off normal daily admission
101-200 visits	15% discount off normal daily admission
201-300 visits	20% discount off normal daily admission
301+	25% discount off normal daily admission



\* If you do not see an option here that fits your organization, call the Community Center Manager to see what other options you may have.

## Corporate Membership Option 2:

You pay an annual fee based on the size of the company and then a monthly fee per participating employee. That employee will receive unlimited admission to the Herndon Community Center for that month.

1-50 employees	\$200 annual fee \$30/month per registered employee
51-200 employees	\$400 annual fee \$30/month per registered employee
201-400 employees	\$500 annual fee \$30/month per registered employee
400+ employees	\$1000 annual fee \$35/month per registered employee

The annual fee will be paid initially by the organization. You can be billed monthly or quarterly for the number of registered employees or employees can pay their own monthly charge. Payments can be made by cash, check, or credit card.

Employees will receive an active pass card for the month. Employees can be added or removed on a monthly basis.
