SECTION I: MAJOR INCIDENTS

Sexual Assault 2/1/2018 600-blk Merlins Ln 2018-00108

Jose Andres Cardona Rodriguez, age 44, of Sterling, VA, was arrested on six counts of sexual assault against juvenile victims known to him. He is being held at Fairfax County Adult Detention Center without bond.

Carjacking 2/3/2018 400-blk Woodgrove Court 2018-00360

The suspect flagged down two people in a vehicle and indicated she needed assistance. When the driver stepped out of the car to assist her, the suspect put her 4-year-old child in the car, and began to drive away. The other passenger was still in the vehicle when the suspect began to drive away, and had to exit it while it was moving. The suspect was later identified as Victoria Johnson, age 30 of Herndon, VA. Johnson was located by police in Prince Georges County, where she is being held. She will be extradited back to Virginia to face charges for carjacking, grand larceny, and contributing to the delinquency of a minor. The victims sustained minor injuries during the incident.
